#### Preamble

Presentations are made regularly to the Board of Directors/Audit Committee (AC) (minutes of the Board Committees are circulated to the Members of the Committees). This helps them to understand the Company's strategy, business model, operations, products, markets, organisation structure, facilities, risk management and such other areas.
