4. Implementation of Sustainable Procurement Policy

As a part of implementation of our Sustainable Procurement Policy, we have established Supplier's Code of Conduct to share commitment of Electrosteel with supply chain partners as described hereunder:

A. Legal Compliance:

Suppliers shall comply with applicable legislation regarding Labour and Human Rights, working conditions, Health and Safety, Environment and Anti-bribery or Anti-corruption practices.

B. Health and Safety:

Suppliers shall provide a safe and healthy workplace environment and shall take effective steps to prevent potential health and safety incidents and occupational injury or illness arising out of an associated occurring in their natural course of work.

C. Labour and Human Rights:

i. <u>Child Labour, Forced or Compulsory Labour:</u>

- Suppliers shall prohibit the use of under aged children at any stage of their business process. We
 expect that our suppliers will not employ any person below the age of 15 (or as per the local law,
 whichever is greater).
- Suppliers are to ensure that remediation policy is available in case under aged children are found to be working at site.
- The Suppliers must not employ forced labour including debt bondage labour and human trafficking.

ii. Working Hours and Remuneration:

We expect suppliers to comply with the applicable laws, regulation and mandatory industry standards pertaining to working hours, minimum wages and provide legally mandated benefits including social insurance.

iii. Developing a culture which discourages any form of discrimination:

Suppliers are to ensure there is no discrimination in their hiring and employment practices on the basis of race, colour, gender, age, nationality, religion, sexual orientation, union membership or any other condition that can lead to some form of discrimination.

D. Business Ethics:

- i. <u>Conflict of interest</u> Suppliers are expected to report issues regarding any conflict of interest during business dealings with Electrosteel. Prompt public disclosure is to be ensured in case anyone under contractual obligation with Electrosteel has significant ownership or interest in a supplier's business.
- ii. <u>Bribery and Corruption</u> Suppliers involved in commercial dealings with Electrosteel must refrain taking illegal means to flourish their business. They should not accept an offer unethically motivated and garnered with lucrative gifts which could be construed as bribes. Electrosteel strongly criticizes acceptance of any illegal payments, gifts, donations in order to obtain unethical favours for the business.
- iii. <u>Confidentiality</u> Suppliers shall safeguard and respect confidentiality related to trade secret, intellectual property, proprietary and sensitive information.

E. Environment:

Electrosteel is committed to comply with environmental laws and reputations. Suppliers are expected to share our concern on maintaining a sustainable environment and take all steps to reduce emission of greenhouse gases and conserve natural resources such water, oil, minerals etc.
